G. Mortgage and Financial Institutions (MFI) Trust [*New]:

"To ensure that people are able to stay in their homes and safeguard the life savings of Americans by protecting our financial system and capital markets, John McCain is calling for the formation of a Mortgage and Financial Institutions Trust (MFI). ...

The MFI will minimize the use of taxpayer money by having an orderly process to address the market crisis. Working with the private sector and regulators, the MFI will help identify troubled institutions and take action to strengthen them before they become insolvent. ...

The MFI Will Be Part Of The U.S. Department Of The Treasury. The MFI will be managed by a board of directors consisting of at least the Secretary of the Treasury, Federal Reserve Chairman, Chairman of the FDIC and two public members. The Secretary of the Treasury will be Chairman of the Board. ...

Troubled institutions will voluntarily come to the MFI.

The MFI will provide liquidity loans at reasonable interest rates. The MFI will receive warrants for controlling interest in troubled institutions.

Troubled financial institutions that enter the MFI will keep operating as private companies with the help of the MFI.

The MFI will supervise the sale of loan assets at market prices and purchase them as necessary.

The MFI will eventually, and at its discretion, sell the loans to the private sector.

The MFI will have a predetermined tenure during which to dispose of the loans.

"During a whirlwind visit to New Orleans, McCain laid out some priorities for the city's recovery. ... He also called for investment in more extensive Category 5 hurricane protection and the restoration of the barrier islands and wetlands that protect New Orleans from storm surge."

J. Labor – National Commission on Workplace Flexibility and Choice [*New]:

"John McCain is calling for [a] National Commission on Workplace Flexibility and Choice. This Commission would bring together a bi-partisan set of leaders representing workers, small and large employers, labor, and academics. K. Labor – Unemployment Compensation for Older Workers:

"John McCain [w]ill [p]rovide [s]pecial, [t]argeted [a]ssistance [f]or [o]lder [w]orkers. Because training is often inefficient for older workers, those 55 years of age and older who have built up

an LEB [Lost Earnings Buffer Account] will be eligible for a Lost Earnings Supplement. The supplement of up to 50 percent of their earnings loss (up to a maximum of \$10,000) for two years will be rewarded for those who find work inside 26 weeks."

Source: Senator McCain has not sponsored or cosponsored any bills related to this issue since the 106th Congress, when he introduced S. 1512: A bill to provide educational opportunities for disadvantaged children, and for other purposes. The bill provided \$1.8 billion a year over three years for states to award scholarships that "may be redeemed for elementary or secondary education for the children at any of a broad variety of public and private schools, including religious schools." The bill also would have eliminated authority to use sugar as collateral for loans and it would have eliminated the sugar price support and production adjustment programs for sugarcane and sugar beets. These reforms would have provided outlay savings to partially offset the costs of the scholarship program.

D. Online Education [*New]:

But I'll encourage the development of infrastructure and market growth necessary for these products to compete, and let consumers choose the winners."
