

## Illinois U.S. Senate Candidate Spending Analysis – Mark Kirk

**Total Net Spending Agenda: \$734 million** 

### Economy, Transportation, and Infrastructure: \$3.181 billion

### A. Lock-and-Dam Upgrades:

"As Senator, Mark Kirk will work to upgrade and expand our river infrastructure to bring our lock-and-dam system into the 21st century." http://www.kirkforsenate.com/?page\_id=377

Cost: \$21 million (\$103 million over five years).

Source: Related legislation has been introduced in the form of H.R. 1770 (111<sup>th</sup> Congress), the Dam Rehabilitation and Repair Act of 2009. H.R. 1770 was previously introduced in the 110<sup>th</sup> Congress as H.R. 3224. The estimate is from a Congressional Budget Office (CBO) report for H.R. 3224 (110<sup>th</sup> Congress).

Representative Kirk did not sponsor either bill.

#### B. Transportation Infrastructure:

"In addition, investments in rail and improvements to our interstate highway system will restore our state's position as the nation's economic crossroads." http://www.kirkforsenate.com/?page\_id=377

Cost: Unknown.

Note: Representative Kirk is a cosponsor of H.R. 3725 (111<sup>th</sup> Congress), the National Highway Chokepoint Congestion Relief Act. The measure would authorize the Secretary of Transportation to make grants available to reduce traffic congestion in national chokepoint regions. A cost estimate is not available.

### C. Expand Regional Rail Service:

• "Connecting the Bloomington-Normal market with the Chicago-St. Louis high-speed rail line is an important piece of the region's economy that Mark Kirk will take to the Senate."

### E. Small Business Bill of Rights:

"Congressman Kirk is the only candidate in this race to propose a Small Business Bill of Rights to protect small businesses from higher taxes, rising health care and energy costs and increasing government red tape."

Cost: \$11 million (\$22 million over two years).

Source: Representative Kirk is the sponsor of H.R. 5109 (111<sup>th</sup> Congress), a bill to establish a tax, regulatory, and legal structure in the United States that encourages small businesses to expand and innovate, and for other purposes. The text authorizes the funding.

### F. International Trade Agreements:

"Allowing exporters to reach new markets is critical for economic growth to continue. That is why Mark Kirk supports passage of the South Korea, Panama and Colombia Free Trade Agreements."

Cost: Unknown.

Note: The primary impact of free trade bills is generally on federal revenues. Depending on the terms of the agreement, there may be some outlays as well. For example, CBO projects that H.R. 3688, the United States-Peru Trade Promotion Agreement Implementation Act (110<sup>th</sup> Congress), "would reduce revenues by \$20 million in 2008, increase revenues by \$292 million over the 2008-2012 period, and reduce revenues by \$423 million over the 2008-2017 period. CBO estimates that enacting H.R. 3688 also would increase direct spending by \$4 million in 2008 and by \$27 million over the 2008-2012 period, and reduce direct spending by \$443 million over the 2008-2017 period. Further, CBO estimates that implementing the legislation would result in new discretionary spending of less than \$500,000 per year, assuming the availability of appropriated funds."

#### G. Revitalize Rockford:

"We must work to expand incentives to bring business to the area, focusing on SBA HUBZones to promote job growth, capital investment, and economic development to historically underutilized business zones. This includes reinvesting in existing infrastructure by cleaning up EPA Brownfield sites to build a strong downtown that can be a boon for the economy." http://www.kirkforsenate.com/?p=1265

Cost: \$373 million (\$1.865 billion over five years).

Source: Related legislation has been introduced in the form of H.R. 4188 (111<sup>th</sup> Congress), to authorize appropriations for Brownfields site assessment and cleanup, and for other purposes. Estimate is based on budget data and the text of the bill.

### Education, Science, and Research: \$86 million

### A. Rural Entrepreneurship Program:

"We must support the establishment of a rural entrepreneurship program with Illinois State University to provide rural entrepreneurs with resources from counseling with the Small Business Development Center staff to access to economic development professionals so their businesses can thrive and expand."

Cost: \$66 million (\$330 million over five years).

Source: Related legislation has been introduced in the form of H.R. 2352 (111<sup>th</sup> Congress), the Job Creation Through Entrepreneurship Act of 2009. Title VII of the bill would authorize grants to Small Business Development Center programs. A CBO cost estimate is available.

"Mark Kirk will continue to support workforce education as he has in his 10<sup>th</sup> Congressional District."

"Rockford College is the only four-year institution in Rockford and we must continue to support it with infrastructure upgrades to improving programs to help increase the quality of education in Rockford."

Note: According to the President of Rockford College earlier this year, "... Congressman [Don] Manzullo and Senator [Dick] Durbin have joined forces to support earmarks totaling \$745,000 over the past three years. These funds have been used to upgrade our technology, classrooms and science equipment." It is unknown how much additional funding Representative Kirk might support.

### Energy, Agriculture, and the Environment: \$17 million

### A. Expand the U.S. Commercial Service:

"As a Senator, Mark will fight to expand the Foreign Commercial Service ... [to] help Illinois farmers and businesses establish and expand exports to growing markets." http://www.kirkforsenate.com/?page\_id=377

Cost: Unknown.

Note: The U.S. Commercial Service is part of the Department of Commerce's International Trade Administration (ITA). According to ITA, "The President's \$534.3 million request [for Fiscal Year 2011] represents a 19.9 percent increase from the FY 2010 request, and an 18.2 percent increase from the FY 2010 budget enacted by Congress. The request is the highest ever for ITA."

#### B. Expand the Small Business Administration:

"As a Senator, Mark will fight to expand ... the Small Business Administration ... [to] help Illinois farmers and businesses establish and expand exports to growing markets." http://www.kirkforsenate.com/?page\_id=377

Cost: \$17 million (\$85 million over five years).

Source: Representative Kirk is a cosponsor of H.R. 2310 (111<sup>th</sup> Congress), a bill to authorize assistance to small- and medium-sized businesses to promote exports to the People's Republic of China, and for other purposes. The text authorizes the funding.

### C. Expand the Department of Agriculture:

"As a Senator, Mark will fight to expand ... the U.S. Department of Agriculture ... [to] help Illinois farmers and businesses establish and expand exports to growing markets." http://www.kirkforsenate.com/?page id=377

Cost: Unknown.

Source: Under the President's Fiscal Year 2011 Budget request, the Department of Agriculture would receive \$27 billion in discretionary budget authority – \$1 billion less than in Fiscal Year 2010. Total spending would rise to \$149 billion, up from \$135 billion the previous year, due to an increase in mandatory budget authority. It is unknown how much additional funding Representative Kirk might support.

## D. Expand the U.S. Trade Development Agency:

Source: The U.S. Trade and Development Agency received \$55.2 million for Fiscal Year 2010. The Administration has requested \$56.2 million, equivalent to an additional \$1 million for Fiscal Year 2011.

### E. Lower Energy Costs:

"To lower energy costs, Mark supports nuclear energy, Yucca Mountain, offshore energy exploration and the trans-Canada pipeline. He also supports streamlining approvals for new refineries and transmission facilities. As a Senator, Mark will support a permanent production tax credit for renewable energy in hydro, win[d], solar and biomass." http://www.kirkforsenate.com/?page\_id=377

Source: Representative Kirk was the sponsor of H.R. 6385 (110<sup>th</sup> Congress), a bill to provide a large-scale national effort to improve the state of our national security, economy and environment by providing market incentives to produce and deploy alternative energy solutions and reduce our dependence on foreign oil. A cost estimate is not available.

### F. Shawnee National Forest:

"As a Senator, Mark Kirk will work to protect our natural resources like the Shawnee National Forest and ensure that Southern Illinois tourism thrives in the 21stcentury [sic]."

## **Health Care: -\$2.575 billion (savings)**

It is unknown whether Representative Kirk would support other spending reductions to offset the elimination of the Medicare cuts. Additionally, Representative Kirk is the sponsor of H.R. 3970 (111<sup>th</sup> Congress), a bill to protect the doctor-patient relationship, improve the quality of health care services, lower the costs of health care services, expand access to health care services, and for other purposes. A cost estimate is not available

### B. Medical Liability Reform:

"With Illinois' state medical liability reform law recently struck down, Congress should pass federal medical liability reform to stop the exodus of doctors from the practice of medicine." http://www.kirkforsenate.com/?p=1946

Source: In a 2009 letter to Senator Orrin Hatch, CBO stated, "Tort reform could affect costs for health care both directly and indirectly: directly, by lowering premiums for medical liability insurance; and indirectly, by reducing the use of diagnostic tests and other health care services when providers recommend those services principally to reduce their potential exposure to lawsuits." The agency estimated potential savings of \$10.3 billion over five years.

Source: Representative Kirk is a cosponsor of H.R. 1590 (111<sup>th</sup> Congress), a bill to provide assistance for the Museum of the History of Polish Jews in Warsaw, Poland. The text authorizes the funding.
