RE:	PRIORITIES OF PENNSYLVANIA VOTERS
DATE:	JUNE 3, 2020

Fabrizio, Lee & Associates recently completed a survey of 600 likely general election voters in Pennsylvania and probed voters on the subjects of technology, the economy, and their priorities for their State Attorney General.

BOTTOM LINE: Pennsylvania voters see the tech industry as a whole and some of the industry leaders very positively. These voters say issues like prosecuting companies that gouge consumers during and after disasters and prosecuting criminals top the list of priorities for their State Attorney General.

• Pennsylvania voters view key tech companies and the industry as a whole positively.

• These voters want their State Attorney General to prosecute price gougers and criminals and crack down on human trafficking. Searching for antitrust violations ranks lowest on the list of priorities.

• Underlining the lack of importance voters place on antitrust probes, investigating companies for such violations is among the top activities these voters would LEAST want a state Attorney General to spend taxpayer money on. • Taking into account the additional stress on Pennsylvania's budget due to the coronavirus crisis, 75% of voters say spending taxpayer money on investigations of companies is just a minor priority or not one at all. Voters across the political spectrum agree saying antitrust issues are only minor priorities on not priorities at all. Just 5% of voters call it a top priority.

METHODOLOGY STATEMENT: Fabrizio, Lee and Associates conducted a survey of 600 likely general election voters in Pennsylvania between May 12-17, 2020 using live call operators dialing from a randomized list of registered voters. Sample frame was stratified to represent likely voter distribution by county & DMA. Landline interviews accounted for 30% of the sample and cell phone interviews 70%. Gender, age, party registration, education and race/ethnicity were weighted to statewide likely voter targets. Margin of error for this survey is +/- 4% at the 95% confidence interval.
