

LOUISIANA

- Voters will decide on three statewide measures that would impact taxes
- Voters will decide on 103 local measures across 34 parishes
- Voters will decide on 95 measures to extend or increase taxes by **\$311.3 million annually**
- Of those tax measures, 86 measures would increase property taxes by **\$263.74 million annually**
- Of those tax measures, 9 measures would increase sales taxes by **\$47.56 million annually**
- Voters will decide on three measures to issue \$63.3 million in bonds
- Voters will decide on 5 measure to permit the sale of alcoholic beverages

STATEWIDE MEASURES

Amendment 1: This measure authorizes the creation of a State and Local Streamlined Sales and Use Tax Commission tasked to provide streamlined electronic filing and remittance of all sales and use taxes.

Tax Impact: N/A. This amendment would set up a central state commission to determine how to shift local sales tax collection to the state level and to develop a new audit process. Importantly, it does not outline what that new processes would look like.

Amendment 2: This amendment would lower income tax rates in exchange for changes to state income tax deductions. These individual and business tax changes would make Louisiana a more attractive place to live, work, and operate a business. To learn more about this measure, [view NTU's op-ed here](#).

Tax Impact: The state constitution currently limits the highest personal income tax rate to 6 percent, but the amendment would lower that cap to a maximum of 4.75 percent. On the corporate side, it would reduce the rate from 8 to 7.5 percent. This reduction is offset by the elimination of the state's federal income tax deduction and the elimination of almost all excess itemized deductions. Taxpayer advocates in Louisiana have noted that this amendment would help simplify the tax code and reduce revenue volatility.

Duration: Permanent

Amendment 3: This amendment would permit levee districts created after 2006 to levy an annual property tax of up to five mills without voter approval.

Tax Impact: While this measure does not directly result in a tax increase, it would take away the ability for voters to decide whether or not they want their tax rates to be increased. Taxpayers deserve the opportunity to determine whether they support or oppose tax increases.

Duration: Permanent

TAX INCREASE [Proposition No. 1](#): Authorizes the imposition of a new parcel fee in order to support drainage operations and flooding prevention.

Tax Impact: A tax increase of **\$71,370 annually**, by imposing an annual fee of \$65 per lot.

Duration: 15 years

BEAUREGARD PARISH

TAX INCREASE [Proposition No. 1](#): Continuation of an expiring parishwide property tax rate to fund public health services.

Tax Impact: A tax increase of **\$684,000 annually**, by extending a property tax rate of 2.42 mills. This rate represents an increase of .18 mills over the previously approved rate.

Duration: 10 years

TAX INCREASE [Proposition No. 2](#): Continuation of an expiring parishwide property tax rate to fund war memorial civic center operations.

Tax Impact: A tax increase of **\$353,300 annually**, by extending a property tax rate of 1.25 mills. This rate represents an increase of .7 mills over the previously approved rate.

TAX INCREASE [Proposition No. 1](#): Continuation of an expiring property tax rate to fund community recreation center operations.

TAX INCREASE [Proposition No. 1](#): Continuation of an expiring town sales tax rate to fund various services.

Tax Impact: A tax increase of **\$431,000 annually**, by extending a sales tax rate of .5 percentage points.

CLAIBORNE PARISH

Town of Haynesville

TAX INCREASE [Proposition No. 1](#): Continuation of an expiring town property tax rate to fund sewage operations.

Tax Impact: A tax increase of **\$41,000 annually**, by extending a property tax rate of 5.04 mills. This rate represents an increase of .04 mills over the previously approved rate.

Duration: 10 years

Wards 2 and 3 Recreation District

TAX INCREASE [Proposition No. 1](#): Continuation of an expiring property tax rate to fund district operating expenses and improvements.

Tax Impact: A tax increase of **\$214,000 annually**, by extending a property tax rate of 5 mills.

TAX INCREASE [Proposition No. 1](#): Continuation of an expiring property tax rate to fund various town projects and operations

Tax Impact: A tax increase of **\$240,000 annually**, by extending a property tax rate of 12.45 mills.

FRANKLIN PARISH

TAX INCREASE [Proposition No. 1](#): Authorizes an increase to the parishwide property tax rate to fund operations and improvements to the parish courthouse.
