RE: KEY CONGRESSIONAL DISTRICT VOTERS ARE CLEAR: EXTEND THE

TRUMP TAX CUTS

DATE: APRIL 16, 2025

As another tax season comes to an end, voters are clear that they want Congress to extend the Trump 2017 Tax Cuts. In a just completed survey of registered voters (RV) in 21 key Congressional districts (see methodology statement on last page), Fabrizio Lee & Associates found that voters, especially Republicans, are strongly in favor of extending the Trump Tax Cuts and doing it as quickly as possible.

Voters Support Extending the 2017 Trump Tax Cuts by a Significant Margin

By a 16-point margin, a majority of voters in these key districts are in favor of Congress extending the 2017 Trump Tax cuts, 52% - 36%. Republicans drive support, with 88% in favor of extending and only 7% opposed, but Independents also favor extending the Tax Cuts by a double-digit margin, 51% - 32%. Only Democrats are opposed to extending the Trump Tax Cuts, and they are not as likely to be opposed as Republicans are to be in favor.

<u>Desire for Congress to Extend the Trump Tax Cuts ASAP to Stop an Increase in Cost of Living, Especially from Republicans</u>

An overwhelming majority of voters agree that it will be harder to pay for things like groceries and utilities if taxes increase, 80% - 17%. Even Democrats, who are largely opposed to extending the Trump Tax Cuts, agree with this statement by a huge margin. A majority of voters STRONGLY agree with this statement, regardless of their political party. It is clear that voters equate higher taxes with a higher cost of living.

To stop a further increase in the cost of living, voters in these key districts agree that Congress needs to act as quickly as possible to make sure the 2017 Trump Tax Cuts do not expire by a 2-to-1 margin, 61% - 31%. Republicans are especially likely to believe this, agreeing by an overwhelming 91% - 7% margin. There is strong intensity behind the Republican support with 74% strongly agreeing -- GOP voters definitely want to see this issue tackled and completed right away.

<u>Information on the Trump Tax Cuts makes Voters, particularly Republicans, More Likely to be</u> <u>in Favor of Extending these Tax Cuts</u> There are several messages about the Trump Tax Cuts and lower taxes in general that make a majority of voters more likely to be in favor of extending the Trump Tax Cuts. For Republicans specifically, well over 80% are more likely to be in favor of extending the Trump Tax Cuts. This strong support for lower taxes, domestic investment, and new jobs propels voter sentiment in favor of extending the Trump Tax Cuts.

I will now read you some statements made by those in favor of extending the 2017 Trump Tax Cuts on individuals and businesses. After I read each, please tell me if what you just heard makes you more likely or less likely to be in favor of Congress extending the 2017 Trump Tax Cuts. BOTTOM LINE: In a group of Congressional districts where the House majority could very well be decided, voters – especially Republicans – are clear in their desire to extend the Trump 2017 Tax Cuts to help catalyze economic growth, American innovation, and create new jobs.

METHODOLOGY STATEMENT: Fabrizio, Lee & Associates conducted a survey of 1,575 registered voters in 21 key Congressional districts, from April 10-14, 2025. The interviews were split 35% live-operator cell phone/25% live-operator landline/40% SMS to web. Gender, age, race/ethnicity, party registration/affiliation, and education were matched to demographic profiles of registered voters based on voter file data and census data on registered voters. Respondents were randomly selected from lists of registered voters in each Congressional district. The margin of sampling error at the 95% confidence interval is ±2.5%. The Congressional districts are AZ-01, AZ-06, FL-04, GA-11, IA-01, IN-05, ME-02, MI-07, NC-01, NE-02, NJ-07, NY-01, NY-02, NY-17, OH-08, PA-01, PA-07, TX-19, TX-34, and WI-03.
